Preamble:-

In connection to the above cited subject, it was noticed illegal dog breeding and marketing without any license and by violating to the orders and rules in reference. Hundreds off dog breeders within the jurisdiction of Palike are undertaking breeding and marketing without any hindrance.

These dog breeders are not taking proper nourishment of the dogs and are engaged in selling unhealthy / infected dog pups and they are breeding 10-15 dogs in a slum area which is found to be piteous. This would also lead to even healthy dog becoming infected.

For the purpose of correcting all these delinquencies and in the interest of welfare of animals the Notification under Ref (1) has been unanimously accepted in the BBMP general body meeting under Ref (2) above for which orders as under.

ORDER

A person who is breeding / undertaking / retaining pet dogs for genetically breeding / engaged in selling of pet dogs and dog pups and the person / institution running dog pups selling shop must have strictly registered with State Animal Welfare Board (SAWB). As provided in Ref (1) above of Ministry of Environmental, Forest and Climate Change, only those person / institution having registered with State Animal Welfare Board (SAWB) may be issued with commercial license

through Bruhat Bangalore Mahanagara Palike (local body)
and hence ordered accordingly.

Preamble:-

In connection to the above cited subject, it was
noticed illegal sales of pet animals / birds at pet
shops by violating to the orders under reference and
without proper license through BBMP.

It is required for undertaking sales of pet animals
/ birds at pet shops should have got registered with

State Animal Welfare Board (SAWB) and avail license through palike.

But dog breeders are not taking proper nourishment of dog pups within the jurisdiction of palike and are engaged in sales of diseased / infected dog pups to the pet shops. This may lead that even healthy dogs may get infected.

For the purpose of correcting all these delinquencies and in the interest of welfare of animals the Notification under Ref (1) has been unanimously accepted in the BBMP general body meeting under Ref (2) above for which orders as under.

ORDER

Any person / institution undertaking retail / wholesale sales of pet animals / birds or any pet shops/ being established / under operation / or purchase or sales of pet animals by whatsoever manner should strictly be registered with State Animal Welfare Board and as provided in Ref (1) above of Ministry of Environmental, Forest and Climate Change, only those person / institution having registered with State

Animal Welfare Board (SAWB) may be issued with commercial license through Bruhat Bangalore Mahanagara Palike (local body) and hence ordered accordingly.
